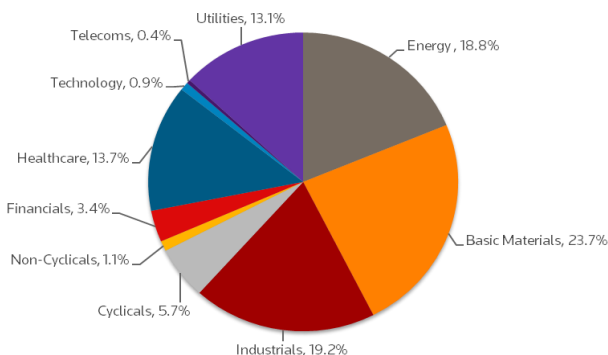
## RESEARCH BASED SCREENING

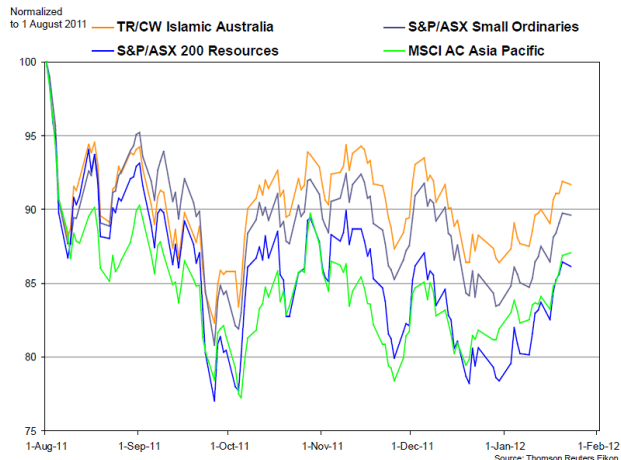
