Recent Legislative Items

Federal

2023 CONG US HR 6363, effective November 16, 2023, amends 42 USCA § 1396r-4 (Adjustment in payment for inpatient hospital services furnished by disproportionate share hospitals) delaying reductions to the Medicaid DSH program until January 20, 2024. The reductions will take effect January 20, 2024, and will continue each year through FY 2027. Amends 42 USCA § 1395w-4 (Payment for physicians' services) extending the physician payment work Geographic index floor from January 1, 2024, to January 20, 2024. Amends 42 USCA § 1395m-1 (Improving policies for clinical diagnostic laboratory tests) delaying by one year the next data-reporting period for certain clinical laboratory tests and the phase-in of payment reductions under the Medicare private payor rate-based Clinical Laboratory Fee Schedule. Amends 42 USCA § 1395iii (Medicare Improvement Fund) increasing the funds, from \$180,000,000 to \$466,795,056, for expenditures from the Fund for services furnished during and after fiscal year 2022. Alaska

2023 AK H.B. 112 (NS), effective November 26, 2023, amends several sections relating to pharmacist licensing. Latest Update available [here](#).

District of Columbia

2023 DC L.B. 73 (NS), effective November 15, 2023, amends DC CODE § 44-501 (Definitions) updating the definition of "ambulatory surgical facility" and adding definitions of "ambulatory surgery," "operating room," "procedure room," and "surgery." Amends DC CODE § 44-504 (Rules) repealing the requirement that the rules for ambulatory surgical facilities list all outpatient surgical procedures that may be performed in a facility licensed as an ambulatory surgical facility. Note: This Act shall take effect following approval by the Mayor, a 30-day period of congressional review, and publication in the District of Columbia Register. Latest Update available [here](#).

Michigan

2023 MI H.B. 4949 (NS), effective February 13, 2024, codifies MI CONST Art. 1, § 28 (Right to reproductive freedom) to provide that the state shall not penalize, prosecute, or otherwise take adverse action against someone for aiding or assisting a pregnant individual in exercising their right to reproductive freedom with their voluntary consent. New York

- 2023 NY A.B. 1297 (NS), effective November 24, 2023, adopts NY PUB HEALTH § 2803-o-1 (Required protocols for fetal demise) requiring hospitals to adopt, implement, and periodically update standard protocols for the management of fetal demise. Establishes requirements for the protocol. Latest Update available [here](#).
- 2023 NY S.B. 1783 (NS), effective May 28, 2024, adopts NY PUB HEALTH § 2803-c-2 (Lesbian, gay, bisexual and transgender, and people living with HIV long-term care facility residents' bill of rights) establishing rights for lesbian, gay, bisexual and transgender, and people living with HIV in long-term care facilities. Provides definitions and specifies that it shall be unlawful for a long-term care facility or facility staff to discriminate against any resident on the basis of such resident's actual or perceived sexual orientation, gender identity or expression, or human immunodeficiency virus (HIV) status. Requires the facility to post certain notices alongside its current nondiscrimination policy. Also establishes record keeping and staff requirements. Latest Update available [here](#).

North Carolina

2023 NC S.B. 49 (NS), effective December 1, 2023, adopts NC ST § 90-21.10A (Definitions), NC ST § 90-21.10B (Parental consent for treatment) and NC ST § 90-21.10C (Penalty) to establish the requirements for a health care practitioner to obtain written or documented consent from a minor child's parent before providing, soliciting, or arranging treatment for the minor child. Pennsylvania

2023 PA H.B. 507 (NS), effective January 20, 2023, adopts PA ST 40 P.S. § 1303.504.1 (Informed consent in pelvic, rectal and prostate examinations) establishing the requirements for informed consent in pelvic, rectal and prostate examinations. Latest Update available [here](#).

2023 WI S.B. 400 (NS), effective December 8, 2023, adopts and amends sections relating to the physician assistant licensing compact. Latest Update available [here](#).

88 FR 78818-01, effective January 1, 2024, amends, adopts and repeals various rules in the following Parts regarding Medicare Part B payment policies and other CMS programs. Updates include revisions to: payment policies under the Medicare physician fee schedule (PFS) and other policy changes related to Medicare Part B payment; the Rural Health Clinic (RHC) and Federally Qualified Health Clinic (FQHC) Conditions for Certification and Conditions for Coverage (CfCs), respectively, implementing provisions to allow payment under Medicare Part B for services furnished by a Marriage and Family Therapist (MFT) or Mental Health Counselor (MHC); the Hospice Conditions of Participation (CoPs) to include marriage and family therapists (MFTs) or mental health counselors (MHCs) as part of the hospice interdisciplinary team and make changes to the hospice personnel requirements; the Medicare Shared Savings Program (Shared Savings Program) and the Quality Payment Program (QPP); the public reporting requirements of procedure volume data (Part B non-institutional claims) on clinician profile pages of the Compare Tool to include Medicare Advantage (MA) encounter data; and the Ambulance Fee Schedule. 2023 AK REG TEXT 653939 (NS), effective January 5, 2024, amends and adopts several sections relating to the licensing of health professionals. Latest Update available [here](#).

Arizona

2023 AZ REG TEXT 647488 (NS), effective November 8, 2023, amends AZ ADC R9-6-1102 (Health Care Provider Requirements) updating language and references from "sexually transmitted diseases" or "STD" to "sexually transmitted infections" or "STI." Latest Update available [here](#).

- 2023 IL REG TEXT 632352 (NS), effective November 22, 2023, amends several sections relating to infection control and disease prevention. Latest Update available [here](#).

Repeals 3 CO ADC 717-1:1.17 (Protections for Provision of Reproductive Health Care in Colorado) and 3 CO ADC 717-1:1.18 (Protecting Colorado's Workforce and Expanding Licensing Opportunities). - 2023 IL REG TEXT 632335 (NS), effective November 8, 2023, amends several sections relating to home health licensing. Latest Update available [here](#).
- 2023 IL REG TEXT 658130 (NS), effective November 24, 2023, adopts 77 IL ADC 250.3 (COVID-19 Emergency Provisions -- At-Home Patient Care) authorizing a hospital to apply for an Acute Hospital Care at Home waiver from the requirements of 42 CFR § 482.23(b) and (b)(1) (Condition of participation: Nursing services) in order to provide limited inpatient services directly in a patient's home and establishing the requirements for doing so. 2023 KS REG TEXT 651949 (NS), effective December 22, 2023, adopts several sections relating to rural emergency hospital licensing. Note: This rulemaking adopts a previous temporary rule (2023 KS REG TEXT 653850 (NS)) as final. Latest Update available [here](#).

Maryland

2023 MD REG TEXT 647697 (NS), effective December 1, 2023, repeals MD ADC 10.24.01, Certificate of Need for Health Care Facilities, and adopts new MD ADC 10.24.01, Procedural Regulations for Health Care Facilities and Services, establishing procedural regulations governing the Commission's certificate of need (CON) and other health planning programs to streamline and modernize the manner in which health care capital projects are reviewed by the Commission. New regulations align the Commission's procedures for reviewing different

types of health care projects, establish and revise deadlines, establish new criteria for reviewing CON applications based in health equity, and provide the Commission with additional flexibility in monitoring approved projects through implementation and addressing public health emergencies. Mississippi

- 2023 MS REG TEXT 639943 (NS), effective December 21, 2023, adopts 30 MS ADC Pt. 3001, Art. LI (Consulting Pharmacists to Ambulatory Surgery Centers and Multi-Provider Clinics) establishing the duties of consultant pharmacists who advise ambulatory surgery centers or multi-provider clinics. Provides that a consultant pharmacist must report to the appropriate regulatory or licensing agency any serious deficiency or violation noted on his/her consultant report if the deficiency is not corrected or addressed by the permit holder by the date of the next monthly visit by the consultant pharmacist at the permit site. - 2023 MS REG TEXT 649953 (NS), effective November 17, 2023, amends multiple sections relating to the licensing of personal care homes and assisted living. Latest Update available [here](#).

- 2023 MS REG TEXT 649958 (NS), effective November 17, 2023, amends 15 MS ADC Pt. 16, Subpt. 1, R. 41.5 (Governing Authority) establishing the requirements for notifying the Mississippi Department of Health of discontinuation of service or closure of the hospital. - 2023 MO REG TEXT 643551 (NS), effective November 30, 2023, amends sections relating to temporary emergency licenses for nursing home administrators. Latest Update available [here](#).
- 2023 MO REG TEXT 648424 (NS), effective October 3, 2023, terminates the emergency adoption of 20 MO ADC 2220-2.410 (Class B Hospital Pharmacy Compounding for Drug Shortages), which allowed Class B hospital pharmacies to compound medication experiencing drug shortages and which was filed June 21, 2023, became effective July 6, 2023, and expires January 1, 2024. Nebraska

2023 NE REG TEXT 641693 (NS), effective November 12, 2023, amends 175 NE ADC Ch. 9 (Hospitals) to restructure the chapter and update the requirements regarding the licensing of hospitals under the Nebraska Health Care Facility Licensure Act. The amendments update definitions; update requirements for criminal background and registry checks for prospective employees; update requirements for standards of operation, care, and services; modify general requirements; update staff requirements, orientation, and credentials; establish standards for the operation of rural emergency hospitals; and establish requirements for administration, records retention, and off-campus, satellite, and mobile units. New Jersey

2023 NJ REG TEXT 656728 (NS), effective October 16, 2023, readopts NJ ADC 10:48B (Decision-Making for the Terminally Ill) without any changes. The chapter sets forth specific guidelines for the Bureau of Guardianship Services (BGS) when making complex end-of-life decisions on behalf of persons served. Further, the chapter provides specific ethical considerations related to decisions to continue or discontinue medical treatment for a terminally ill person with intellectual/developmental disabilities. 2023 NM REG TEXT 642573 (NS), effective December 5, 2023, amends several sections relating to physician licensing and disciplinary actions. Latest Update available [here](#).

- 2023 OH REG TEXT 651142 (NS), effective November 30, 2023, repeals, reenacts, and amends multiple sections in OH ADC 4731 (Medical Board) to update the requirements regarding the mandatory reporting of violations for impaired practitioners and procedures for impairment cases. Oregon

2023 OR REG TEXT 657080 (NS), effective January 1, 2024, adopts OR ADC 851-031-0041 (Governor Declared Emergency) allowing the Board to impose limited RN licenses to individuals holding an active and unencumbered nursing license at the same level in another state or U.S. jurisdiction during an emergency declared by the Governor. Rhode Island

- 2023 RI REG TEXT 650992 (NS), effective November 22, 2023, amends 210 RI ADC 50-05-2.4 (Personal Needs Funds - Requirements) to increase the threshold amounts for certain personal needs funds from \$50 to \$75. Provides that when the individuals balance exceeds \$75 the excess shall be deposited into an certain accounts and the amount of petty cash - resident personal needs account must not exceed \$75. Readopts 210 RI ADC 50-05-2.3 (Definitions) and 210 RI ADC 50-05-2.5 (Assisted Living Residences) without any changes. Latest Update available [here](#).
- 2023 RI REG TEXT 652777 (NS), effective November 27, 2023, amends 216 RI ADC 40-20-5 (Therapeutic Radiation Machines) to keep pace with current technology and address future technological advances in therapeutic radiation machines. Adds, amends, and removes definitions; prohibits the use of a therapeutic radiation machine that has not received U.S. Food and Drug Administration (FDA) clearance or premarket approval; updates requirements throughout the rules; and adds requirements for a dedicated quality management program to control the processes used to administer therapeutic radiation with newly acquired, FDA-cleared emerging technologies or previously unused features of a future technology system. - 2023 TX REG TEXT 652564 (NS), effective December 4, 2023, amends 22 TX ADC § 291.3 (Required Notifications) to require a pharmacy to notify the board in writing if the pharmacy temporarily closes for the loss of a pharmacist-in-charge. Utah

- 2023 UT REG TEXT 649890 (NS), effective November 1, 2023, repeals and reenacts UT ADC R432-101 (Specialty Hospital—Psychiatric) to update licensure standards for the operation of a psychiatric hospital. The rule outlines standards of patient care that apply to psychiatric hospital inpatient, outpatient, and satellite services. This rule applies to a licensee that chooses to be licensed as a psychiatric specialty hospital and whose single major service is psychiatric service. If a psychiatric specialty hospital licensee chooses to have a dual service, including psychiatric and substance abuse or chemical dependency, then both of the specialty hospital rules apply. The purpose of this repeal and reenactment is to make significant language and structure changes to replace outdated language with the Utah Rulewriting Manual standards. - 2023 UT REG TEXT 650968 (NS), effective November 9, 2023, amends UT ADC R432-270 (Assisted Living Facilities) to update the licensing and operational standards for assisted living facilities. The amendments include more specific language consistent with the Rulewriting Manual for Utah; updating titles and citations due to the recodification of the Department of Health and Human Services' statute; adding additional training requirements for the facility administrator in addition to core competency training; and making other clarifying and conforming changes. Virginia

2023 VA REG TEXT 650613 (NS), effective November 27, 2023, adopts and amends sections relating to the discharge of residents from assisted living facilities. Latest Update available [here](#).

Washington

- 2023 WA REG TEXT 654406 (NS), effective November 17, 2023, rescinds emergency rules WA ADC 388-97-1081 (Reimplementation of 3.4 hours per resident day minimum staffing standards), WA ADC 388-97-1082 (Reimplementation of 24-hour registered nurse staffing standards) and WA ADC 388-97-1091 (Reimplementation of registered nurse minimum staffing standards) that were filed under WSR 23-20-105 on October 3, 2023. - 2023 CO REG TEXT 652351 (NS), effective December 30, 2023, adopts new 3 CO ADC 702-3:3-1-18 (Concerning the Climate Risk Disclosure Survey) with the following sections: Section 1 (Authority), Section 2 (Scope and Purpose), Section 3 (Applicability), Section 4 (Definitions), Section 5 (Rules), Section 6 (Severability), and Section 7 (Enforcement). Requires insurers, on or before August 31, 2024, and each year thereafter, to submit a completed "NAIC Climate Risk Disclosure Survey." Latest Update available [here](#).
- 2023 CO REG TEXT 653286 (NS), effective January 1, 2024, amends 3 CO ADC 702-4:4-2-43 (Enrollment Periods Relating to Individual and Group Health Benefit Plans) by adding that dependent coverage cannot be terminated, on the basis of age, before the end of the plan year in which the dependent attains age 26. 2023 FL REG TEXT 648263 (NS), effective December 19, 2023, amends 69 FL ADC 690-238.001 (Application and Renewal) by removing the requirement that an applicant for initial registration as a pharmacy benefit manager submit Form OIR-C1-2210, Registration Form for Pharmacy Benefit Managers Invoice, and removing the mailing address for submission of the application fee and Form OIR-C1-2210; requiring that registrants renewing their registration submit Form OIR-C1-2209, Registration Form for Pharmacy Benefit Managers, rather than form OIR-C1-2210; and directing registrants renewing their registrations to submit the renewal fee and Form OIR-C1-2209 electronically via the iApply system, rather than by mail. Includes in the definition of "utilization review entity" an individual or entity that performs prior authorization review for a health benefits plan provided through Medicaid. Specifies that a health benefits plan provided through Medicaid may require prior authorization based on a

preferred drug list. Defines "long-term services and supports" and provides that a utilization review entity must provide a decision on long-term services and supports within 30 days, provided that the enrollee has been determined to be eligible for such benefits under Medicaid. Provides that the Department of Health Care Finance may require annual reauthorization for long-term services and supports. Latest Update available [here](#).

Specifies that the division shall reimburse a nursing facility for services provided to a NJ FamilyCare beneficiary residing in a single occupancy room at an enhanced per diem reimbursement rate equal to 150 percent of the nursing facility's base per diem reimbursement rate, provided that, on any date after the effective date of this act, the nursing facility voluntarily delicensed beds in order to establish the single occupancy room in which the beneficiary resides. Specifies how reimbursements received by a nursing facility that are in excess of the facility's base per diem reimbursement rate shall be utilized by the facility.
