

Part 1: Log in and log out

RI Feeds is accessible via the Internet from any computer using the latest versions of Internet Explorer[®], Google Chrome[™], Firefox[®] or Safari[®] (with auto-updates turned on). Google Chrome is recommended for optimal user experience and performance.

Click on the following link to access RI Feeds: <u>https://login.accelus.com</u>

Once you are on the login page, you will be prompted to enter your OnePass username and password*.

*Please note: In order to first access RI Feeds, you are required to create a OnePass profile (or update an existing profile) using the registration key provided to you via your Account Activation email. If you require assistance with the OnePass login, please refer to the OnePass Quick Start Guide.

Upon logging in, you may be presented with the following options, from which you will select RI Feeds.

Once you have logged in, you will be able to view the following sections and options directly from the Homepage.

RI Feeds Home (1):

Selecting the RI Feeds home icon will reload the site.

Note: For customers with access to the Regulatory Intelligence application, you will be presented with the option to access the Regulatory Intelligence Application or RI Feeds as depicted in 1.1 Log In.

Published & Draft Feeds Toggle (2):

The Published & Draft Feeds toggle located at the top left-hand side of the screen provides the ability to load any published or draft feed details.

By default, the Published tab is selected and any feeds that are published and therefore actively delivering content will be presented in the table.

Selecting the Draft button allows you to load and view any feeds that are in the process of being configured and that have not yet been published (i.e., actively delivering content). When selected, the table will display all the applicable feeds.

Home (3):

The drop-down menu allows you to move easily between the Homepage, Settings and Create Feed sections.

Search (4):

For customers with access to the Regulatory Intelligence application, you will be provided with access to the Global Search control. This control allows you to conduct a global search on RI by inputting keyword(s). When you enter the keywords, the system will generate a drop-down list of suggested documents. You can choose to click on any of these documents directly or hit **Enter** to return a full list of related results. Refer to **4.1.2.1 Add content from search** for more details on search options.

Delete Feeds (5):

This button allows you to permanently delete feeds that you no longer require when the associated feed's checkbox is selected.

Create Feed (6):

This button allows you to create a new feed.

Once you have loaded Settings, you will be able to view the following sections and options.

Settings menu (1):

This menu provides access to your Delivery Locations and Taxonomy settings.

By default, the Delivery Locations tab is selected and any existing delivery locations for your organization that have been configured by yourself or any fellow users under the same account will be presented. This allows you to manage the delivery locations used by your account.

Add delivery location (2):

This button allows you to add a new delivery location to your account, which can be used for the delivery of feed files and taxonomy data.

View delivery location details (3):

Click the title of your configured delivery locations to view their details.

Delete delivery location (4):

The delete button found beside a delivery location will allow you to permanently remove settings. Please note that this will only be enabled for delivery locations that are not currently in use.

Location name: The unique title that will be used as a reference for your delivery location.

Server url/IP address: The address of your SFTP site.

Port: The port number to be used for your SFTP server. Typically, this is "2222" by default.

Root Directory: The location within your SFTP server where your content will be deposited. If the content is expected to be deposited into the default directory, this should be defined as ".".

Username: The username associated with your SFTP account.

Password: The password associated with your SFTP account.

Save & Cancel: The save button allows you to save the SFTP account settings. Please note that all fields are required before you are allowed to save your settings.

The cancel button navigates you back to the Delivery Locations main page.

Note: If any settings are applied when this is clicked, they will be permanently lost.

You will be presented with the details of the selected delivery location.

Location name: The title of the selected delivery location.

Server url/IP address: The address of your SFTP site.

Port: The port number to be used for your SFTP server.

Root Directory: The location within your SFTP server where your content will be deposited. If the content is expected to be deposited into the default directory, this should be defined as ".".


Username: The username associated with your SFTP account.

Password: The password associated with your SFTP account.

Edit button (top right): This allows you to amend the SFTP settings.

Back button: This button navigates you back to the Delivery Locations main page.

3.1.3 Manage delivery location settings



When viewing the details of a Delivery Location that you would like to amend (see **3.1.2 View delivery location settings**), click the edit button located at the top right-hand side of the screen.

When viewing your list of defined delivery locations (see Part **3.1 Delivery locations**), click the trash can icon (located under the Actions column) for the delivery location you wish to delete.

You will only be allowed to remove delivery locations that are not in use.

Please note, you will be prompted to confirm the deletion of the selected delivery location before it is fully removed.

3.2 Taxonomy

You will find that RI Feeds content references Thomson Reuters classifications by a unique reference ID, which represents precise taxonomy values within the set hierarchy. To ensure that you are able to decipher these values and make full use of the classified data, we provide the ability to receive the taxonomy source files.

The following section provides information on how to configure your account to receive this data.

From the Settings area, select **Taxonomy** from the left menu.

3.2 Taxonomy


While the Taxonomy Delivery settings are undefined, you will be presented with the form that you can configure to deliver the taxonomy files to the desired location.

Delivery Location (1): You are provided with the ability to have your taxonomy files delivered to one of your existing SFTP locations or delivered to an email address.

Taxonomy Subscription (2): This option allows you to automatically receive taxonomy file updates when changes are published.

Save (3): Once you have defined all required taxonomy delivery settings, you can either simply save the settings or save the settings and request for the current version to be delivered.

After taxonomy delivery settings are saved by yourself or by any fellow users under your organization's account, each time you visit this area you will be presented with the stored taxonomy delivery settings.



3.2 Taxonomy

Edit Taxonomy Delivery Settings (1):

This button allows you to amend your taxonomy delivery settings.

Delivery Location Settings Summary:

The contents of this page provide a summary of the delivery location details that are currently in use.


Where the taxonomy delivery settings are configured to use an SFTP location, you will be presented with the SFTP address and port. Where the delivery location is set as an email address, you will be presented with the applied value.

If you have selected to automatically receive taxonomy file updates, then this setting will also be indicated here.

Send the latest taxonomy now (2):

This button allows you to manually request the delivery of the current version of the taxonomy file.

See **3.2.1 Deliver taxonomy to SFTP** and **3.2.2 Deliver taxonomy to email** for more details on how to configure this section.



3.2.1 Deliver taxonomy to SFTP

You can use the Delivery Location option in the Taxonomy Delivery Settings to define to which of your existing delivery locations the taxonomy file will be delivered.


From the Settings, Taxonomy page, select the Delivery Location radio button. Click the drop-down list labelled **Select Delivery Location** to expand the list of SFTP sites that have been configured and are available (if the list is empty, please see **3.1.1 Configure delivery locations**).

Select the appropriate delivery location.

If you would like to automatically receive taxonomy file updates when changes are made, then select the check box labelled **Send taxonomy files as they are updated**.

Once you are satisfied with the SFTP delivery location settings applied, you can click the **Save** button to store your settings or click **Save and send taxonomy now** to both store your SFTP settings and to immediately deliver the current version of the taxonomy file to your specified location.

Upon clicking either option, you will be presented with a summary of the settings applied.



3.2.2 Deliver taxonomy to email

You can use the Email option in the Taxonomy Delivery Settings to define an email address to which the taxonomy file will be delivered.

From the Settings, Taxonomy page, select the Email radio button.


In the text field, provide a single email address that will receive the taxonomy file.

Please note that your email provider may prevent receipt of the taxonomy file emails. If this is the case, please speak to your systems administrator or select an alternative delivery setting.

If you would like to automatically receive taxonomy file updates when changes are made, then select the check box labelled **Send taxonomy files as they are updated**.

Once you are satisfied with the email location settings applied, you can click the **Save** button to store your settings or click **Save and send taxonomy now** to both store your email settings and to immediately deliver the current version of the taxonomy file.

Upon clicking either option, you will be presented with a summary of the settings applied.



3.2.3 Manage my taxonomy delivery settings

From the Settings, Taxonomy page, click the edit button found at the top right-hand side of the screen.



3.2.4 On-demand taxonomy delivery

From the Settings, Taxonomy, Taxonomy page, click the **Send the latest taxonomy now** button located in the lower portion of the screen.


Part 4: Feeds

Before feeds can be configured, a valid delivery location will need to be created. If you haven't done so already, please review section **3.1 Delivery locations**.

4.1 Configure draft feeds

From anywhere in the RI Feeds Web application, expand the drop-down menu located at the top left-hand side of the screen and select the **Create New Feed** option.

Alternatively, you can click the **Create Feed** button located at the top right-hand side of the Homepage Published and Draft screens.



4.1.1 General Detail

In the General Detail section of the Create Feed form, all that is required is for you to input a unique name for your feed in the *Feed name* field.

Basic details of the feed will be automatically populated and displayed here, including:

Status: The status of feeds will remain "draft" until they are published and become active.

Created by: The details of the user that created the feed.

Created on: The date that the feed was first created and saved.

4.1.2 Feed Content

The Feed Content section of the Create Feed form allows you to define the data that will be included in your feed files, where the following options are provided:

Content (1): This drop-down list provides the ability to add content to your feed file using "Add from Search" or "Add from Library". See **4.1.2.1 Add content from Search** and **4.1.2.2 Add content from Library** for more details.

Content Includes (2): Using the Content Includes drop-down, you can select to receive either the current version of your selected content (also referred to as a baseline file) and all updates moving forwards, or just the content updates.

4.1.2.1 Add content from Search

Search enables you to define parameters in order to capture refined results, relevant to your organization, while reducing the "noise" of extraneous information.

From the Create Feed, Feed Content section, expand the Content drop-down list and select the **Add from Search** option.


The following parameters can be selected for an Advanced Search:

Keyword: Using the Guided Boolean search, you can monitor content containing specific words, terms or phrases and also exclude content that contains specific terms.

Date Restrictions: Allows you to restrict your search results to specific time periods.

Date Types: You can further narrow your search by selecting from a series of regulatory event date types such as Effective Date, Source Publication Date, Approval Date, e.t.c. Click on the + icon to view the event date types in full.

Please see the Appendix for the full list of date types and definitions.



4.1.2.1 Add content from Search

Filter Parameters:

Geography: Allows you to narrow down your search to a specific region or regions:

- Europe
- Africa
- Asia
- North America
- Australia and Oceania
- Middle East
- Latin America and Caribbean

By choosing a region, you will be selecting all countries in that specific region. Alternatively, you can expand the region to show the list of underlying countries or regions to make the selection at that level (for example, select **North America** > select **United States of America** > select **Federal** or any of the underlying states). If you do not specify any geographical region, the system gives results from all regions. **Sector:** Allows you to narrow your search to specific sectors:

- Banking
- Insurance
- Securities and Commodities
- Human Resources
- Healthcare

You can also drill down further within certain sectors (for example, **Banking** > **Retail-Mortgage lending**). If you do not specify a sector, the system gives results from all sectors.

Content Type: Enables you to restrict your search to one of five major categories:

- Legislative Materials
- Executive Materials
- Regulatory Materials
- Editorial Summaries and Analysis
- Secondary Sources

You can also drill down further within each category (for example, **Legislative Materials** > **Statutes**). If you do not specify a content type, the system gives results from all types. **Organizations:** This lets you narrow your search for information published by specific organizations:

- Central Banks
- Courts and Tribunals
- Government Departments and Ministries
- International and Regional Bodies
- Legislative Bodies
- Publishers
- Regulators
- SROs, Exchanges, ATSs and Clearing Agencies
- Trade Associations

You can drill down further within each organization type (for example, **Central Banks** > **Federal Reserve**). If you do not specify an organization, the system gives results from all organizations.

4.1.2.1 Add content from Search

Themes: Enables you to narrow your search to specific themes:

- Entity Establishment and Governance
- Internal Oversight
- Business Activities
- Business Conduct Standards
- Regulatory Structure and Oversight

You can also further refine your search within each general theme (for example, **Business Activities** > **Offerings** > **Beneficial Ownership**). If you do not specify a theme, the system gives results from all themes.

All the above criteria work in an AND relationship.

For example, if a user specifies the following criteria for search:

Keyword: Reform

Geography: UK

Sector: Banking

then the search results will contain the keyword "reform" and will be taxonomized to "UK" and "banking."

When a keyword is specified, the system carries out a Googlelike search to return results that carry the keyword in their title or anywhere in the body text.

Click the **Save as Feed** button once you have configured the search to capture the desired content.

This will return you back to the feed settings page.





4.1.3 **Delivery settings**

The Delivery Settings section of the Create Feed form provides the ability to define two main details:

1. Frequency

2. Delivery (location)

The following sections go into more detail regarding how to configure each area.

4.1.3.1 Frequency

The Delivery Settings, Frequency area will provide the following options for you to determine the schedule for which your content will be sent.

Start Date: The date from which your feed will be active and you will start to receive data. Please note that this cannot be the current day or any historical days.

Frequency: Allows you to control how often your content is delivered: daily, weekly or monthly.

Time: Allows you to define the time at which the feed will execute and be delivered in Greenwich Mean Time (GMT). A maximum of three deliveries per day per feed can be configured.

Note: The Time control only becomes active upon selecting a valid frequency value.



At any point, you are free to save your feed settings by clicking the **Save** button located at the bottom of the Create Feed form.





Expected Future DateThis defines a date when a regulatory event is expected to happen.	
Expiration Date	This is the end date of an interim or temporary rule.
Filing Date	This is the date when an SRO (State Regulatory Organization) submits the rule for filing with the SEC.
Publication Date	This is the date when Thomson Reuters publishes a document – such as a news, analysis or regulatory event.
Source Publication Date	This is the date when the source document was published by the source regulator/organization.
